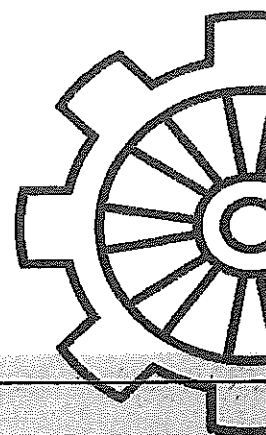
**ALLOCATION OF TENDER BA07/03/2017: APPOINTMENT AS SHORT –TERM INSURANCE


