1. Project Description and scope of services

1.1. Background

The Steve Tshwete Local Municipality in process of planning and designing a precinct of a mixed-use development that will cater for businesses including motor sales market, commercial and high density purposes, roads and public open spaces Portion 365 of the Remainder of Portion 27 of the farm Middelburg Town and Townlands 287 JS which stretches over 46 hectares of land. The parameters of the proposed development are maximum of 70% coverage, 1 – 5 storey buildings, Floor Area Ratio ranging between 0,7 – 2,1 and maximum housing density of 80 dwelling units per hectare. The draft concept plan is hereby attached to this document.

In line with the principles of sustainable development, experienced and registered geologists are hereby invited to submit quotations for conducting engineering geological investigation on the 46 hectares of land in order to assess the suitability of the site for the purpose of planning and designing additional stands. - 2.4 **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of services, works or goods, through price quotations, advertised competitive bidding processes or proposals;
- 2.5 **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- 2.6 **“comparative price”** means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- 2.7 **“consortium or joint venture”** means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;

- 2.9 **“EME”** means any enterprise with an annual total revenue of R5 million or less;

- 5.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

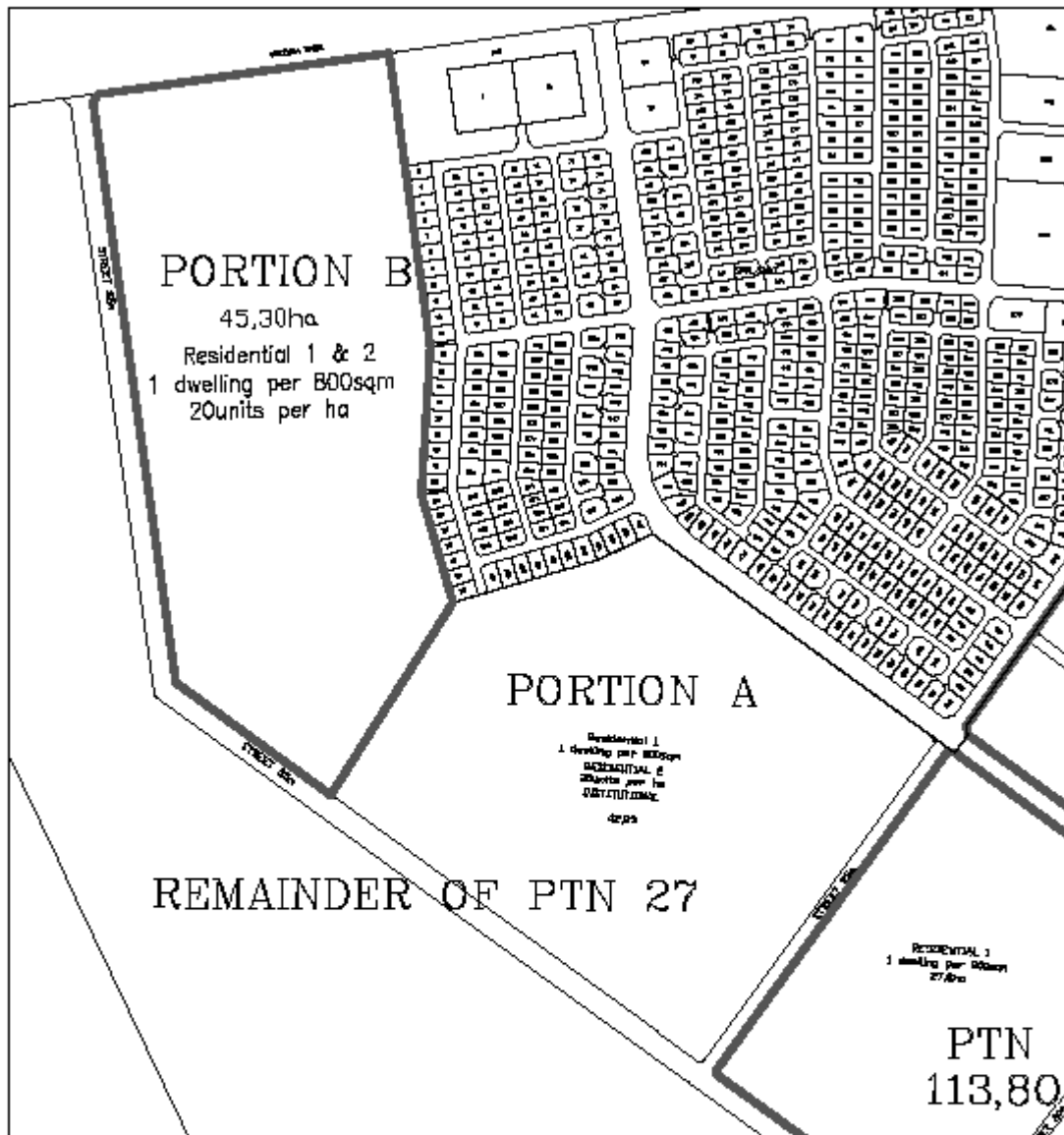
