TAX CLEARANCE CERTIFICATE REQUIREMENTS

C3 SCOPE OF WORKS / SPECIFICATIONS

1. INTRODUCTION ND

The Municipality treats and distribute portable throughout Middelburg area. The chlorine levels deteriorate within the distribution network hence a chlorine booster station is installed at one of the bulk water storage reservoirs.

The principal features of the scope of works do not limit the responsibility of the contractor. He shall perform all work and furnish all labour, equipment and material to ensure the satisfactory operation of the chlorine booster station.

2. PURPOSE AND RECIPIENTS

The purpose of this project is to maintain the microbiological quality of the portable water supplied to the eastern parts of Middelburg Town, particularly but not limited to Nazareth, Hlalamnandi, Extension 24, Rockdale, Dennesig and Kanonkop.

3. TERMS OF REFERENCE

The *contractor* will provide the following:

1. All plant, material, transport and labour required for the supply, delivery, off-loading, installation, test and commissioning of the chlorine booster station. The booster station shall consists of 2x 70kg chlorine cylinders with an automatic changeover system.
2. Operating manuals and training as specified.
3. Supply and install all material required to connect to the chlorine cylinders are operate the system safely,
4. Testing, commissioning and handing over of the completed installation.

7. CONSTRUCTION PROGRAMME

The submission of a construction programme as stated per clause 15 of the general conditions of contract is compulsory.
