1. Description of the goods required

Supply, delivery and off-loading of 20 ton graded silica sand for Krugerdam Water Treatment Plant

Specifications

- Dry graded silica sand for application in water treatment processes.
- SANS approved product.
- Granular sizes range 600 – 700mm
- Contained in bags of 40 – 50 kg

2. Compliance to Bid Specification

In a case where the bidder intend to supply an Equivalent of the units described in paragraph 1 above; the bidder is required to supply the equivalent specifications of the units. Failure to do so will result in disqualification due to non-responsiveness to bid specifications.

3. Delivery of goods

Delivery of the units is Krugerdam Water Treatment Works. The supplier should ensure that the unit is delivered at the right place and that it is received in good condition.

4. Information Required by the Municipality

The bidder will be required to submit a 500g sample of the graded silica sand. Submission of the sand sample can be at the Krugerdam Water Treatment Plant on the closing date of the bid, alternatively per arrangement with the technical contact person whose details are shown above.

5. Reimbursement and Submission of a Sand Sample

The Municipality will not reimburse the bidder for submission of the required 500g sand sample nor will the Municipality reimburse any cost associated with sourcing, handling, storage and/or delivery of the required sand sample. Failure to submit the required sand sample will result in the bid being disqualified.

The total costs of the required goods including delivery to Middelburg. The price of the unit should be firm until delivery date. Delivery period should be clearly indicated

MBD 2: TAX CLEARANCE CERTIFICATE REQUIREMENTS

It is a condition of bid that the taxes of the successful bidder must be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations.

Bidders are required to submit original and valid B-BBEE Status Level Verification Certificates or certified copies thereof together with their bids, to substantiate their B-BBEE rating claims.

2. It serves as a declaration to be used by municipalities and municipal entities in ensuring that when goods and services are being procured, all reasonable steps are taken to combat the abuse of the supply chain management system.
3. The bid of any bidder may be rejected if that bidder, or any of its directors have:

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
