**TERMS OF REFERENCE FOR DEVELOPMENT OF POLICY ON DEVELOPMENT CHARGES IN
TERMS OF THE SPATIAL PLANNING AND LAND USE MANAGEMENT ACT NO. 16 OF 2013**

1. Project Description and Scope of services

According to 2011 Census, the population residing within the Steve Tshwete municipal area was estimated at 228 2200 with an estimated growth rate of about 4,7%. The mines, power stations and industrial developments taking place around the geographic area of the Steve Tshwete Local Municipality are the pull factors that encourage people to immigrate to Middelburg, Mhluzi, Hendrina, Kwazamokuhle towns and other Eskom towns in search of job opportunities. The migration of people to these towns has among other things, created a demand for housing and serviced stands. These factors have led Steve Tshwete to be declared as one of the fast growing mining towns.

Due to population growth, the existing residential, business and institutional stands have been found to be insufficient to address the demand. The demand for residential stands exists across the whole spectrum of housing income categories. Huge demand is at the low income housing and affordable housing income categories.

Sufficient provision for serviced stands has been a challenge since the municipality does not have enough financial and land resources to address the demand. Again, experience has taught the municipality that demand for stands is not only from the residents of the Steve Tshwete Local Municipality, but it is also from people who are not from this municipality but willing to relocate to this municipality for settling and business purposes. As a result, it becomes difficult to project accurate demand for residential stands.

Notwithstanding the above, the municipality endeavours to plan and supply serviced stands through the establishment of integrated human settlements within the confines of the available and limited resources.

As part of the development process experienced and registered consultants are hereby invited to submit quotations for conducting a wetland delineation study and Riparian Ecological Study on a 82 hectare piece of land in order to assess the suitability of the site for the purpose of planning and developing an integrated human settlement. The specialist studies must be conducted in line with the stipulations of the regulations of the National Environmental Management Act 107 of 1998. The appointment of consultant will be done in terms of Regulation 16(1) read together with Regulation 17 of the Act. The content of the specialist report must comply with Regulation 32 of the Act.

- 2.7 “**consortium or joint venture**” means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- 2.8 “**contract**” means the agreement that results from the acceptance of a bid by an organ of state;
- 2.9 “**EME**” means any enterprise with an annual total revenue of R5 million or less;
- 2.10 “**Firm price**” means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11 “**functionality**” means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.12 “**non-firm prices**” means all prices other than “firm” prices;
- 2.13 “**person**” includes a juristic person;
- 2.14 “**rand value**” means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 2.15 “**sub-contract**” means the primary contractor’s assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;

- 2.16 “total revenue” bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
- 2.17 “trust” means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- 2.18 “trustee” means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.
- 3.6 Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.
