In terms of Section 110 of the Municipal Finance Management Act, 2003 (No. 56 of 2003), tenders are hereby invited for the upgrading of the Boskrans Waste Water Treatment Works. Tenders are hereby invited for the **UPGRADING OF THE VAALBANK WATER TREATMENT PLANT ELECTRICAL MOTOR CONTROL PANELS** in the Steve Tshwete municipal region. The works comprises of the mechanical-electrical works. **Tenderers should have a CIDB contractor grading of 3ME or 3EP and higher.**

Tender documents will be obtainable on the 17/11/2017 during office hours, from Ms Rose Kalies, Department of the Director Legal & Administration, Room B207, Municipal Building, Wanderers Avenue, P.O. Box 14, Middelburg, Mpumalanga 1050, Tel: (013) 249-7365 & Fax: (013) 243-2550) against payment of a non-refundable tender amount of R500.00. Only bank guaranteed cheques or cash will be accepted. Cheques shall be made payable to the Steve Tshwete Local Municipality. Duly completed tender enclosed in a sealed envelope marked **"TENDER NO. BS01/10/2017: UPGRADING OF THE VAALBANK WATER TREATMENT PLANT ELECTRICAL MOTOR CONTROL PANELS"** with the name of the tenderer, shall be deposited in the tender box provided at the Steve Tshwete Local Municipality on the 1st floor, Civic Centre, Wanderers Avenue, Middelburg, before 12H00 on 07/12/2017. The tenders will be opened in public.

A compulsory clarification meeting with representatives of the employer will take place at the Vaalbank WTW (29°28'57.67"E 25°49'14.81"S) MIDDELBURG on 27/11/2017 starting at 10h00 hrs. Contract documentation will not be available on site, and the engineer will not be available for inspection purposes on any other occasion.

*Bidders will be evaluated on functionality whereby **70 points** has to be attained before financial proposals can be looked at. A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the conditions of tender in the tender document, read in conjunction with the supply chain management policy of Steve Tshwete Local Municipality where 80 points will be allocated in respect of price and 20 points in respect of B-BBEE Status Level of Contribution. Tenderers must have the necessary skills, experience and capacity to perform the required work.*

No awards will be made to a person:

- Who is in the service of the state;
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.

Contractors who have the following are eligible to tender and must provide such proof:

- **Original certified copy of valid BBEE certificate (non-compulsory, failure to submit no points will be awarded)**
- **Company registration certificate(CK)**
- **Valid Tax Clearance certificate & SARS Pin and reference number**
- **Copy of current municipal account or lease agreement with account of tenderer and account of lessor to the municipality (not older than 3 months)**
- **Attach copy of CSD report**
- **Valid proof of registration with CIDB on 3ME or 3EP or higher.**
