The closing time for receipt of tenders is **12:00hrs** on **2017/04/11** Telegraphic, telephonic, telex, facsimile, e-mail, unmarked and **late tenders** will under no circumstances be considered and accepted. The tender box will be emptied just after closing time on the closing date. Hereafter all bids will be public.

A compulsory clarification meeting with representatives of the employer will take place at the Mechanical Workshop training room, CNR Walter Sisulu and Protea road, Middelburg, Mpumalanga on Wednesday, 2017/03/23 starting at 10H00 am. The envelope must be endorsed with number, title and closing date as indicated above..

Bidders will be evaluated on functionality whereby 70 points has to be attained before financial proposals can be looked at. A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Steve Tshwete Local Municipality where 90 points will be allocated in respect of price and 10 points in respect of B-BBEE Status Level of Contribution.

No awards will be made to a person:

Who is in the service of the state;

If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.

Contractors who have the following are eligible to tender and must provide such proof.

- Original certified copy of valid B-BBEE certificate (non-compulsory, failure to submit no points will be awarded)
- Certified copy of current municipal account (not older than three months)
- Central Supplier Database (CSD) report must be attached
- Original certified CK documents
