*A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Steve Tshwete Local Municipality where **80 points** will be allocated in respect of price and **20 points** in respect B-BBEE Status level of contribution.*

Tenderers must have the necessary skills, experience and capacity to perform the required work. Tenderers must have the necessary skills, experience and capacity to perform the required work. Only those tenderers/bidders/company's who score a minimum score of **70 points in respect of at least one area of responsibility** will proceed to the price and preference goals evaluation. **Tenderers who fail to score the required minimum points for functionality on a specific area of responsibility, will not further be evaluated on price and B-BBEE in respect of such area of responsibility.**
