Cheques shall be made payable to the Steve Tshwete Local Municipality.

Duly completed tender enclosed in a sealed envelope marked "TENDER NO. BS05/02/2017: SUPPLY, DELIVERY AND INSTALLATION OF CABLE BETWEEN LANG SUBSTATION TO HOOP MINIATURE SUBSTATION IN CBD" with the name of the tenderer, shall be deposited in the tender box provided at the Steve Tshwete Local Municipality on the 1st floor, Office B207, Civic Centre, Wanderers Avenue, Middelburg, before 12H00 on 2017/03/28. The tenders will be opened in public.

A compulsory clarification meeting with representatives of the employer will take place at the Electrical Workshop training room, CNR Walter Sisulu and Protea road, Middelburg, Mpumalanga on Wednesday, 2017/03/22 starting at 10H00 am. Bidders who arrive 10 minutes late will not be allowed to sign attendance register as such will not be eligible to tender. Contract documentation will not be available on site, and the engineer will not be available for inspection purposes on any other occasion

Bidders will be evaluated on functionality whereby 70 points has to be attained before financial proposals can be looked at. A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the conditions of tender in the tender document, read in conjunction with the supply chain management policy of Steve Tshwete Local Municipality where 90 points will be allocated in respect of price and 10 points in respect of B-BBEE Status Level of Contribution. Tenderers must have the necessary skills, experience and capacity to perform the required work.

No awards will be made to a person:

- Who is in the service of the state;
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.

Contractors who have the following are eligible to tender and must provide such proof:

- Original certified copy of valid B-BBEE certificate (non-compulsory, failure to submit no points will be awarded)
- Certified copy of current municipal account (not older than three months)
- Valid proof of registration with CIDB on 4 EP/ 3EP PE or higher.
- A copy of Company registration must be attached.
- CSD Summery Report must be attached.
