BS05/07/2017: TENDER TITLE SUPPLY, DELIVER AND INSTALLATION OF 400M X 2.1M ANTI CLIMB, ANTI-VANDAL, ANTI CUT HIGH SECURITY WELDED WIRE MESH FENCE AT SERVICE CENTRE (MAGASYN)" with the name of the tenderer, shall be deposited in the tender box provided at the Steve Tshwete Local Municipality on the 2nd floor, Civic Centre, Wanderers Avenue, Middelburg, before **12H00 on 15/08/2017**. The tenders will be opened in public.

A compulsory clarification meeting with representatives of the employer will take place at the Municipal Service Centre, Cnr Walter Sisulu Street and Protea street, Middelburg on **WEDNESDAY, 02/08/2017** starting at **10H00** hrs. Contract documentation will not be available on site, and the Project Manager will not be available for inspection purposes on any other occasion.

Bidders will be evaluated on functionality whereby 70 points has to be attained before financial proposals can be looked at. A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the conditions of tender in the tender document, read in conjunction with the supply chain management policy of Steve Tshwete Local Municipality where 80 points will be allocated in respect of price and 20 points in respect of B-BBEE Status Level of Contribution. Tenderers must have the necessary skills, experience and capacity to perform the required work.

No awards will be made to a person:

Who is in the service of the state;

If that person is not a natural person , of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or

Who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.

Contractors who have the following are eligible to tender and must provide such proof:

Original certified copy of valid B-BBEE certificate (non-compulsory, failure to submit no points will be awarded)

Company registration certificate(CK)

Original ,valid Tax Clearance certificate and SARS Pin and reference (Tax status must be tax compliant at closure of bid)

Copy of current municipal account (not older than three months)

Copy of CSD registration document and tax status must be tax compliant for total period of bid evaluation

Valid proof of registration with CIBD on 2SQ or Higher or higher.
