### **Tenders are herewith invited for the supply of TYRES: New, RE-Treading and other tyre related works as and when required for a period of 36 months**

In terms of Section 110 of the Municipal Finance Management Act, 2003 (No. 56 of 2003), tenders are hereby invited for the panel of service providers of tyres: New, re-treading and other tyre related works as and when required for a period of 36 months

The closing time for receipt of tenders is **12:00hrs** on **2018/03/06**. Telegraphic, telephonic, telex, facsimile, e-mail, unmarked and **late tenders** will under no circumstances be considered and accepted. The tender box will be emptied just after closing time on the closing date. Hereafter all bids will be **opened in public**.

A compulsory clarification meeting with representatives of the employer will take place at Cnr Walter Sisulu and Protea Road, Municipal Mechanical Workshop, Stores (Magasyn), Middelburg, Mpumalanga, 1050 on 2018/02/13 starting at 10H00 hrs. A bidder who arrives 10 minutes late will not be allowed to sign attendance register as such will not be eligible to tender. Duly completed tender enclosed in a sealed envelope separately marked **“TENDER NO. BS06/08/2017: “Panel of service providers of TYRES: New, re-treading and other tyre related works as and when required for a period of 36 months” with the name of the tenderer, shall be deposited in the tender box provided at the Steve Tshwete Local Municipality on the 1<sup>st</sup> floor, Office B207, Civic Centre, Wanderers Avenue, Middelburg, before 12H00 on 2018/03/06. The tenders will be opened in public**

A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Steve Tshwete Local Municipality where **80 points** will be allocated in respect of price and **20 points** in respect of B-BBEE Status Level of Contribution. **Tenderer has to score minimum of 60 out of 100 for functionality** to be evaluated further on price and BBEE.

No awards will be made to a person:

- Who is in the service of the state;
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.
