Cheques shall be made payable to the Steve Tshwete Local Municipality.

The closing time for receipt of tenders is **12:00hrs on 29/01/2019**. Telegraphic, telephonic, telex, facsimile, e-mail, unmarked and **late tenders** will under no circumstances be considered and accepted. The tender box will be emptied just after closing time on the closing date. Hereafter all bids will be public.

A compulsory clarification meeting with representatives of the employer will take place at the Mayor's Boardroom, Civic Centre, Cnr Walter Sisulu and Wanderers Avenue, Middelburg, Mpumalanga, 1050 on 15/01/2019 starting at 11h00. Contract documentation will not be available on site.

Fully completed tender documents, clearly marked "**Tender No. BS06/12/2018: DEVELOPMENT OF MUNICIPAL WIDE BUSINESS CONTINUITY PLAN AND ITS ASSOCIATED DISASTER RECOVERY PLAN OVER THE 2018/19, 2019/20 AND 2020/21 FINANCIAL YEARS**" with "**NAME of TENDERER**" must be placed in a sealed envelope and placed in the tender box on the 1st floor, **Steve Tshwete Municipality, Civic Centre, Corner Walter Sisulu and Wanderers Avenue, Middelburg**, by no later than 12h00 on 29/01/2019. The envelope must be endorsed with number, title and closing date as indicated above.

A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Steve Tshwete Local Municipality where 80 points will be allocated in respect of price and 20 points in respect of B-BBEE Status Level of Contribution. Only bidders that score a minimum score of 70 points will be evaluated for price and BBBEE.

No awards will be made to a person:

- Who is not registered on the Central Supplier Database;
- Who is in the service of the state;
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.
