A PANEL OF MAXIMUM (02) TWO SERVICE PROVIDERS FOR THE SUPPLY AND DELIVERY OF BOTTLED WATER AND REFRESHMENTS AS AND WHEN REQUIRED FOR A PERIOD OF 18 MONTHS

In terms of Section 110 of the Municipal Finance Management Act, 2003 (No. 56 of 2003), tenders are hereby invited for a **panel of two service providers for the supply and delivery of bottled water and refreshments as and when required for a period of 18 months**

Tender documents and specifications are available and can be obtained from Ms. Rose Kalies, Legal & Administration Department, Room B207, Municipal Building, Corner Walter Sisulu and Wanderers Avenue, P.O. Payments can be made through bank guaranteed cheque payable to the Steve Tshwete Local Municipality or cash.

The closing time for receipt of tenders is **12:00hrs** on **04/09/2018**. Telegraphic, telephonic, telex, facsimile, e-mail, unmarked and **late tenders** will under no circumstances be considered and accepted. The tender box will be emptied just after closing time on the closing date. Hereafter all bids will be public.

A compulsory briefing session will take place on 21/08/2018 at 10:00 at the Gerard Sekoto Library Auditorium, Civic Centre. Any technical enquiries relating to the tender document may be directed to the Assistant Director Communications, Ms Prudence Magutle at 013 249 7053.

Fully completed tender documents, clearly marked "**Tender No. BS07/04/2018: a panel of two service providers for the supply and delivery of bottled water and refreshments as and when required for a period of 18 months**" with "**NAME of TENDERER**" must be placed in a sealed envelope and placed in the **tender box** on the **1st floor**, Steve Tshwete Municipality, Civic Centre, Wanderers Avenue, Middelburg, **by no later than 12h00 on 04/09/2018**. The envelope must be endorsed with number, title and closing date as indicated above..

A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Steve Tshwete Local Municipality where 80 points will be allocated in respect of price and 20 points in respect of B-BBEE Status Level of Contribution.

No awards will be made to a person:

- Who is not registered on the Central Supplier Database;
- Who is in the service of the state;
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.

Pre-qualifying criteria for preferential procurement shall be applied. Bids will be pre-qualified on two (2) criteria for preferential procurement. Only bidders that meet the following pre-qualifying criteria shall be considered:

- > Criteria 1: Only Bidders with a BBBEE Level 1 or Level 2 Certificate will be considered.
- > Criteria 2: Only local suppliers will be considered (STLM MP313 area)
