CALLING FOR TENDERS FOR THE CONSTRUCTION OF A RISING MAIN FROM VAALBANK WATER TREATMENT PLANT TO SKIETBAAN RESERVOIRS

In terms of Section 110 of the Municipal Finance Management Act, 2003 (No. 56 of 2003), tenders are hereby invited for the construction of a rising main from vaalbank water treatment plant to skietbaan reservoirs, in the Steve Tshwete municipal region. **Tenderers should have a CIDB contractor grading of 5CEPE or higher.**

Only bank guaranteed cheques or cash will be accepted. Cheques shall be made payable to the Steve Tshwete Local Municipality.

Duly completed tender enclosed in a sealed envelope marked "**TENDER NO. BS09/03/2018: CALLING FOR TENDERS FOR THE CONSTRUCTION OF A RISING MAIN FROM VAALBANK WATER TREATMENT PLANT TO SKIETBAAN RESERVOIRS**" with the name of the tenderer, shall be deposited in the tender box provided at the Steve Tshwete Local Municipality on the 1 st floor, Civic Centre, Wanderers Avenue, Middelburg, before 12H00 on 19/04/2018. The tenders will be opened in public.

A compulsory clarification meeting with representatives of the employer will take place at the Training Centre, Cnr Walter Sisulu and Protea road, Middelburg on 11/04/2018 starting at 10:00 . Contract documentation will not be available on site, and the engineer will not be available for inspection purposes on any other occasion.

*Bidders will be evaluated on functionality whereby **60 points** has to be attained before financial proposals can be looked at. A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the conditions of tender in the tender document, read in conjunction with the supply chain management policy of Steve Tshwete Local Municipality where 80 points will be allocated in respect of price and 20 points in respect of B-BBEE Status Level of Contribution. Tenderers must have the necessary skills, experience and capacity to perform the required work.*

No awards will be made to a person:

- Who is in the service of the state;
- If that person is not a natural person , of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity?

The Municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The Municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.

- Copy/ printed Tax Clearance Certificate or Tax compliance status Pin to enable the municipality to verify the bidder's tax compliance status- Compulsory
- Copy of current municipal account (not older than 3 months) – copy of Lease Agreement – Compulsory
- CSD summary report – Compulsory
- Valid proof of registration with CIDB on 1CE or higher- Compulsory
