Cheques shall be made payable to the Steve Tshwete Local Municipality.

The closing time for receipt of tenders is **12:00hrs** on **2019/02/14**. Telegraphic, telephonic, telex, facsimile, e-mail, unmarked and **late tenders** will under no circumstances be considered and accepted. Hereafter all bids will be read in public.

A non-compulsory clarification meeting with representatives of the employer will take place at Cnr Walter Sisulu and Protea Road, Mechanical Workshop, Service Centre (Magasyn), Middelburg, Mpumalanga, 1050 on 2019/02/05 starting at 10h00. Contract documentation will not be available on site.

Fully completed tender documents, clearly marked "**Tender No. BS16/01/2019: Supply and delivery of a one ton LDV by an accredited dealer.**" with "**NAME of TENDERER**" must be placed in a sealed envelope and placed in the tender box on the 1<sup>st</sup> floor, **Steve Tshwete Municipality, Civic Centre, Corner Walter Sisulu and Wanderers Avenue, Middelburg**, by no later than 12h00 on 2019/02/14. The envelope must be endorsed with number, title and closing date as indicated above.

A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Steve Tshwete Local Municipality where 80 points will be allocated in respect of price and 20 points in respect of B-BBEE Status Level of Contribution.

No awards will be made to a person:

- Who is not registered on the Central Supplier Database;
- Who is in the service of the state;
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.
