In terms of Section 110 of the Municipal Finance Management Act, 2003 (No. 56 of 2003), tenders are hereby invited for the supply and construction of asphalt surface, base correction, milling and replace with btb, slurry seal, crack sealing and chip and spray as and when required for a period of thirty six (36) months

The closing time for receipt of tenders is **12:00** on **30/05/2018**. Telegraphic, telephonic, telex, facsimile, e-mail, unmarked and **late tenders** will under no circumstances be considered and accepted. The tender box will be emptied just after closing time on the closing date. Hereafter all bids will be public.

A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Steve Tshwete Local Municipality where 80 points will be allocated in respect of price and 20 points in respect of B-BBEE Status Level of Contribution.

No awards will be made to a person:

- Who is not registered on the Central Supplier Database;
- Who is in the service of the state;
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.

**NB\* COMPULSORY BRIEFING SESSION**

**Contractors who have the following are eligible to tender and must provide proof of such:**

- One (01) pre-qualifying criteria for preferential procurement shall be applied. Bids will be pre-qualified on criteria for preferential procurement. Only bidders that meet the following pre-qualifying criteria shall be considered:

- Pre-qualifying criteria 1: Minimum BBBEE Level 1 or 2 Certificate. Original certified copy of valid BBBEE certificate/sworn affidavit must be attached. A tender that fails to meet this pre-qualifying criteria stipulated is an unacceptable tender.

**The following documents have to be attached (Bidders that fail to submit documents indicated as compulsory will be disqualified)**

- **Original certified copy of valid BBBEE Certificate (non-compulsory, failure to submit no points will be awarded) only SANAS accredited or Affidavits will be accepted.**
- **Copy of company registration certificate(CK) - Compulsory**
- **Copy/ printed Tax Clearance Certificate or Tax compliance status Pin to enable the municipality to verify the bidder's tax compliance status- Compulsory**
- **Copy of current municipal account (not older than 3 months) – copy of Lease Agreement – Compulsory**
- **CSD summary report – Compulsory**
- **Valid proof of registration with CIBD on 5 SB PE or higher- Compulsory**
- **Copy of Bank Rating if the bid amount is above R2 million – Compulsory**
- **Company's latest 3 years Audited Financial Statement if the bid amount is above R10 million - Compulsory**
