A non-compulsory clarification meeting with representatives of the employer will take place at Community Services boardroom, Cnr Walter Sisulu and Wonderers Street, Middelburg, Mpumalanga, 1050 on 10/04/2019 starting at 14h00. Contract documentation will not be available on site.

Bids will be pre-qualified in accordance with functionality criteria as outlined in the tender. Only the bids that meet the minimum number of 60 points out of the total number of points for functionality will proceed to the price and preference goals evaluation stage.

The closing time for receipt of tenders is at 12H00 on 17/04/2019. Telegraphic, telephonic, telex, facsimile, e-mail and late tenders will not be accepted.

Duly completed tender enclosed in a sealed envelope marked "TENDER NO. The tenders will be opened in public.

A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Steve Tshwete Local Municipality where **80** points will be allocated in respect of price and **20** points in respect B-BBEE Status level of contribution.
