Tenders are hereby invited for the **appointment of a panel of maximum three(3) contractors (as and when required) for the supply and installation of valves, manhole covers and bulk water meters in steve tshwete local municipality area for /a period of 36 months**

in the Steve Tshwete municipal region. **Tenderers should have a CIDB contractor grading of 1CE or higher.** The contract comprises mainly of construction work of Replacing pipes, installing valves, compaction and replacing Paving..

Cheques shall be made payable to the Steve Tshwete Local Municipality.

Duly completed tender enclosed in a sealed envelope marked "TENDER NO. BS22/03/2018 appointment of a panel of maximum three(3) contractors (as and when required) for the supply and installation of valves, manhole covers and bulk water meters in steve tshwete local municipality area for /a period of 36 months" with the name of the tenderer, shall be deposited in the tender box provided at the Steve Tshwete Local Municipality on the 1 st floor, Civic Centre, Corner Walter Sisulu and Wanderers Avenue, Middelburg, before 12H00 on **08/05/2018**. The tenders will be opened in public.

A compulsory clarification meeting with representatives of the employer will take place at the Workshop Boardroom: CNR Walter Sisulu and Protea road, MIDDELBURG on 19/04/2018 starting at 10h00 hrs. Contract documentation will not be available on site, and the engineer will not be available for inspection purposes on any other occasion.

Bidders will be evaluated on functionality whereby 70 points has to be attained before financial proposals can be looked at. A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the conditions of tender in the tender document, read in conjunction with the supply chain management policy of Steve Tshwete Local Municipality where 80 points will be allocated in respect of price and 20 points in respect of B-BBEE Status Level of Contribution. Tenderers must have the necessary skills, experience and capacity to perform the required work.

No awards will be made to a person:

- Who is in the service of the state;
- If that person is not a natural person , of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity?

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.

NB: : Only locally produced or manufactured goods, meeting the stipulated minimum threshold for local production and content, will be considered in line with Regulation 8(2) of the Municipal Supply Chain Management Regulations and National Treasury Circular 69."

- **Local content is applicable as per MBD 6.2- Compulsory**
