In terms of Section 110 of the Municipal Finance Management Act, 2003 (No. 56 of 2003), tenders are hereby invited for the UPGRADE OF CALL MANAGER SYSTEM .

Payments can be made through bank guaranteed cheque payable to the Steve Tshwete Local Municipality or cash.

The closing time for receipt of tenders is **12:00** on **26/09/2018**. Telegraphic, telephonic, telex, facsimile, e-mail, unmarked and **late tenders** will under no circumstances be considered and accepted. The tender box will be emptied just after closing time on the closing date. Hereafter all bids will be public.

A compulsory clarification meeting with representatives of the employer will take place at Cnr Wanderers Avenue and Walter Sisulu Street, Community Services Boardroom, Middelburg, Mpumalanga, 1050 on 18/09/2018 starting at 10:00. **Failure to attend the briefing is automatic disqualification. No late bidders will be allowed in the boardroom after 10:00.** Contract documentation will not be available on site. Only bidders who scored a minimum **70 points** for functionality will be further evaluated on price and BBBEE.

Fully completed tender documents, clearly marked "**Tender No. BS22/08/2018: UPGRADE OF CALL MANAGER SYSTEM**" with "**NAME of TENDERER**" must be placed in a sealed envelope and placed in the **tender box** on the **1st floor**, Steve Tshwete Municipality, Civic Centre, Corner Walter Sisulu and Wanderers Avenue, Middelburg, **by no later than 12:00 on 26/09/2018**. The envelope must be endorsed with number, title and closing date as indicated above.

A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Steve Tshwete Local Municipality where **80 points** will be allocated in respect of price and **20 points** in respect of BBBEE Status Level of Contribution.

No awards will be made to a person:

- Who is not registered on the Central Supplier Database;
- Who is in the service of the state;
- If that person is not a natural person , of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.

Pre-qualifying criteria for preferential procurement shall be applied. Bids will be pre-qualified on the criteria for preferential procurement. Only bidders that meet the following pre-qualifying criteria shall be considered:

- Criteria 1: Only Bidders with a BBBEE Level 1 and 2 Certificate will be considered.
