Tenders are hereby invited for the appointment of a panel of contractors (as and when required) for the construction of sewer networks in steve tshwete local municipality area for a period of 36 months, in the Steve Tshwete municipal region. **Tenderers should have a CIDB contractor grading of 1CE or higher.**

The tenders will be opened in public.

A compulsory clarification meeting with representatives of the employer will take place at the **Electrical Workshop Boardroom: Cnr of Walter Sisulu and Protea road, Middelburg** on **24/04/2018** starting at **14:00** Contract documentation will not be available on site, and the engineer will not be available for inspection purposes on any other occasion.

*Bidders will be evaluated on functionality whereby **60 points** has to be attained before financial proposals can be looked at. A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the conditions of tender in the tender document, read in conjunction with the supply chain management policy of Steve Tshwete Local Municipality where **80 points** will be allocated in respect of price and **20 points** in respect of B-BBEE Status Level of Contribution. Tenderers must have the necessary skills, experience and capacity to perform the required work.*

No awards will be made to a person:

- Who is in the service of the state;
- If that person is not a natural person , of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity?

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.
