## C3 SCOPE OF WORKS / SPECIFICATIONS

Steve Tshwete Local Municipality seeks to acquire services of a qualified supplier with CIDB grading of 1CE or higher, for the refurbishment of humus tank and chlorine system for Blinkpan Waste Water Treatment Plant. The plant is located in Blinkpan area and purifies sewage from the households within Blinkpan and nearby areas. One of the steps in the purification process is aeration of raw sewage followed by settling/clarification inside a settling tank. Clarification process requires that the unit meets certain operational requirements in order to effectively separate solids and liquid. The RFQ seeks to cover the overall refurbishment of the clarifier.

Chlorine system at this plant operates at a low water pressure and requires a boost to ensure sufficient water carrier for chlorine gas. This would be done by supplying and installing a new Jojo tank and a suitable booster pump.
