## C3 SCOPE OF WORKS / SPECIFICATIONS

### 1. INTRODUCTION AND BACKGROUND

The Municipality is experiencing illegal dumping and littering around the residential areas and CBD. It is on this premise that the services of a service provider is required for the supply, delivery and installation of Semi-underground bins system to assist the Municipality to manage illegal dumping and littering in hot spots areas.

- The Semi-underground bins unit must be installed in such a way to empty each system within a 2 minute period.
