C3 SCOPE OF WORKS / SPECIFICATIONS

INTRODUCTION AND BACKGROUND

Council requires the services of a private contractor to carry out services for supply and installation of concrete palisades fencing at Barlow park substation

1. PURPOSE AND RECIPIENTS

1.1 The contractor will only work on site with workers that understand, accepted and have signed for the following procedures:

2. QUALIFICATIONS

- First Aid;
- Safety Induction Course;
- Pre Task Planning, Risk Assessment, Workers register;
- Refusal to work;
- Work Procedure.

3. PHYSICAL RESOURCE

- The contractor must have a LDV that is licensed.
- The contractor must have a mobile toilets licensed on side for the workers.
- The contractor is responsible to supply the worker with an overall, safety hat, gloves and safety boots or other personal protective equipment that may be required.
- All required road signs for working next to road surfaces must be provided by the contractor.

No contractor or his workers are allowed to work in close proximity or on the following equipment of Council:

- Crane truck
- Cable jack
- Cable car
- Cherry picker
- Hydraulic equipment.

4. Trenches Requirements

- The services of the contractor will be required for the digging of trenches, assistance with laying of cables into the trenches, closing of trenches, compacting and cleaning up of sites:

Trench width 300 to 400mm and depth 600 to 1 200mm

5. TERMS OF REFERENCE

➤ SPECIFICATIONS

- Contractor must comply with the following specifications:

The contractor must provide his/her own tools and equipment.

➤ Performance Requirement (strength)

The required concrete compressive strength in all pre-fabricated pre stress elements shall be a minimum of 30 Mpa at b32 days, determine in accordance with SABS method 863

➤ Pre-stressing steel

All wire shall be of the crimped variety and shall be free of rust, loose scale, flux, grease, or oils stances and shall in general comply with the SABS.

➤ **POST:**

- The post shall be 3.0m long and slotted, to take the horizontal load bearing rails.
- The front edge shall be curved
- The back section shall be 100mm wide tapering from the front 60mm.
- The thickness of the post shall be 165mm.
- Post shall be spaced at 2.0m centre

- The posts shall be stressed with 4x4mm wire grade 1550/1700Mpa, stressed to 75% of the u.s.t. (Ultimate tensile strength)
- Pre stressed wire shall be cut at surface level and sealed.
- The top of the pole shall be the angle of 45 degrees Celsius

➤ **Pales:**

- The shall be 204mm long with two 10mm holes to take 8mm carriage type bolts
- The front edge shall be curved
- The back shall be 70mm wide tapering to the front to 60mm
- The thickness of the pale shall be 55mm
- Pales are spaced at +/- 190mm centre

➤ **Rails:**

- The rails shall be 1.98m long with eleven 10mm holes to take 8mm carriage type bolts
- The rails shall be 125mm wide and 55mm deep, all rails are to be ground into posts.

➤ **Gate**

- Gate should be made of anti theft fencing 2.8m high x 3m with rolling wheels (sliding gate) and locking mechanism, the mechanism should be able to accommodate municipal locks

➤ **Erection:**

- Each post shall be embedded to full depth in concrete in a foundation hole of at least 460mm x 460mm and a depth of 600mm

- All work must be coordinated and scheduled through: Electrical Workshop, Engineering Technicians, instruction will be done in a form of works order. No work shall commence without a written works order.

- Risk assessment and Pre-task planning must be done with each task

- Should the contractor not comply with the special conditions of the contract, the Director Electrical Engineering service will give a written warning. All work will be stopped until the contractor has given a written response on how he will rectify the situation to the acceptance of the Director Electrical Engineering service. If there is a recurrence, the order will be cancelled.

- All existing services will be indicated to the contractor and, if necessary, exposed. The contractor is responsible or liable for damage to any existing services (water, gas, telecommunication, electricity and sewer)

- Contractor must provide water to the site as and when necessary. Written permission must be obtained from the Civil Engineering Services department to withdraw water from the fire hydrant at the services centre.

- Contractor must provide piping and water and no standing time will be paid due to unavailability of those..

- A first aid box must be in the vehicle when work is being carried out.

- All work must be done in accordance with the Occupational Health and Safety Act;

- All services present will be indicated on site after which pilot holes must be dug to determine the depth of the existing services before commencement of the work.

- Any damages to services indicated will be recovered from the contractor.

- Any damages of services that belong to the community it will be the responsibility of the contractor to repair such services.
