C3 SCOPE OF WORKS / SPECIFICATIONS

1. INTRODUCTION AND BACKGROUND

Due to the high numbers of veld fires received and attended to by this department it is imperative to have sufficient equipment.

2. TERMS OF REFERENCE/SPECIFICATIONS

The duties of the Service Provider is to supply and deliver high quality skid units which must meet the following specifications:

- Unit must have a 500l water tank
- Unit tank must be baffled against water surge. Baffles must be removable
- Unit must easily slide or lifted on and off a bakkie
- Tank must be manufactured from LLDPE material with a minimal wall thickness of 8mm and have a 3-year warranty against fractures or similar material.
- The frame must have a base plate to fit the pump and assembly
- The pump assembly must have a fully enclosed belt drive and pulley cover but easily adjustable
- The tank must have a drain valve at the bottom that can be screwed off to dump water if necessary.
- The tank dimension must be not more than 1020mm in length 1220mm in width and 470mm in height.
- The total height of the skid unit and pump must not exceed 1040 mm.
- There must be at least 4 tie-down eye-lids on top of the frame for secure fastening to your bakkie truck bed
- The unit must be fitted with one G20 Aluminium pistol grip discharge nozzle with hydraulic type quick release coupling
- The hose reel must be of a heavy duty design with solid disc ends, sturdy mounting frame fixed to the top frame with manual rewind handle and be able to fit 30m of hose.

- Tank lid must have a minimum diameter of 200mm, which must be properly secured to the tank so that during filling operations lid remains to unit.

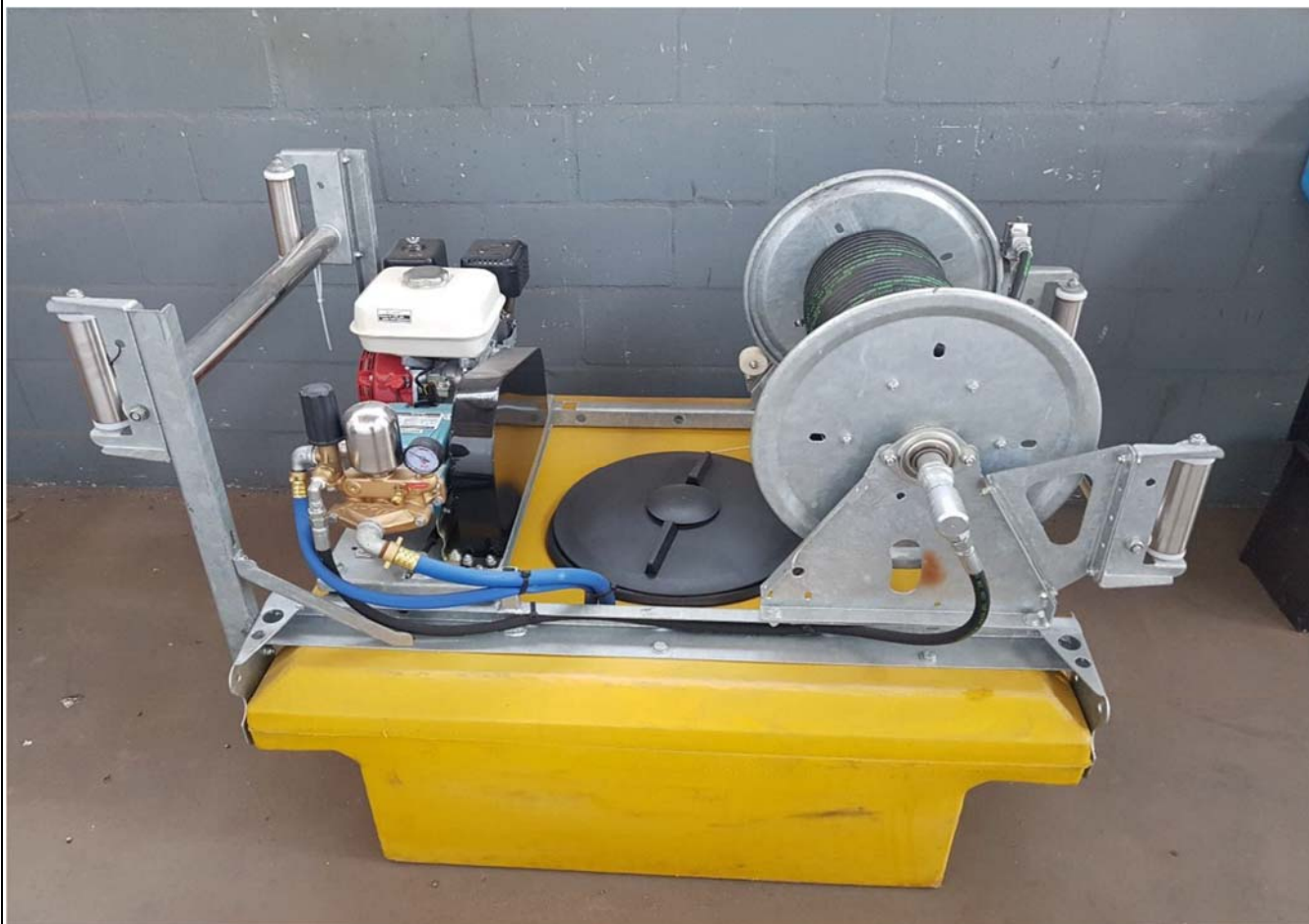
