In terms of Section 110 of the Municipal Finance Management Act, 2003 (No. 56 of 2003), tenders are hereby invited for the SUPPLY AND DELIVERY OF UNIFORM AND PPE FOR STEVE TSHWETE PUBLIC SAFETY PERSONNEL AS AND WHEN REQUIRED FOR A PERIOD OF 36 MONTHS.

Only payments made in cash or debit/credit card will be accepted.

The closing time for receipt of tenders is **12:00** on **31/08/2022**. Telegraphic, telephonic, telex, facsimile, e-mail, unmarked and **late tenders** will under no circumstances be considered and accepted. The tender box will be emptied just after closing time on the closing date. Hereafter all bids will be public.

Fully completed tender documents, clearly marked "**Tender No. BS02/06/2022: SUPPLY AND DELIVERY OF UNIFORM AND PPE FOR STEVE TSHWETE PUBLIC SAFETY PERSONNEL AS AND WHEN REQUIRED FOR A PERIOD OF 36 MONTHS**" with "**NAME of TENDERER**" **must be placed in a sealed envelope and placed in the tender box** provided by **Steve Tshwete Municipality on the 1st floor, Room B 207, Civic Centre, Corner Walter Sisulu and Wanderers Avenue, Middelburg**, by no later than 12h00 on **31/08/2022**. The envelope must be endorsed with number, title and closing date as indicated above.

SAMPLES:

- As part of the approval process, the bidders will be required to submit **at least one (1) sample of every PPE product offered** for purposes of testing of quality and workmanship.
- Samples (marked with the bid and item number as well as the bidder's name and address) **shall be delivered separately** to the bid to the Municipal Central Stores (Magasyn) corner Walter Sisulu and Protea Street, Middelburg, by no later than 12h00 on **31/08/2022**.
- Bids may not be included in parcels containing samples.
- If samples are not submitted as required in the bid document, then the bid concerned may be declared invalid.
- Samples shall be supplied by a bidder at his/her own expense and risk. The municipality shall not be obliged to pay for such samples.
- If a bid is accepted for the supply of goods according to a sample submitted by the bidder, that sample will become the contract sample. All goods/materials supplied shall comply in all respects to that contract sample.
- **BIDDERS NEED TO ALLOW ENOUGH TIME TO SUBMIT BOTH THEIR TENDER DOCUMENTS AND SAMPLES AT THE 2 (TWO) RESPECTIVE ADDRESSES BY NO LATER THAN 12H00 ON 31/08/2022**

A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Steve Tshwete Local Municipality where 80 points will be allocated in respect of price and 20 points in respect of B-BEE Status Level of Contribution.

No awards will be made to a person:

- Who is not registered on the Central Supplier Database;
- Who is in the service of the state;
- If that person is not a natural person , of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.

NB: Only locally produced or manufactured goods, meeting the stipulated minimum threshold for local production and content, will be considered in line with Regulation 8(2) of the Municipal Supply Chain Management Regulations and National Treasury Circular 69.”

The exchange rate to be used for the calculation of local production and content must be the exchange rate published by the South-African Reserve Bank (SARB) at 12:00 on the date of advertisementof the bid; and

Only the South-African Bureau of Standards (SABS) approved technical specification number SATS 12863:2011 must be used to calculate local content.

The following documents have to be attached as Annexure A (Bidders that fail to submit documents indicated as compulsory will be disqualified)

- **Original certified copy of valid BBBEE Certificate (non-compulsory, failure to submit no points will be awarded) only SANAS accredited or Affidavits will be accepted.**
- **Copy of company registration certificate(CK) – Compulsory**
- **Copy/ printed Tax compliance status Pin to enable the municipality to verify the bidder’s tax compliance status- Non-Compulsory**
- **Copy of current municipal account (not older than 3 months) or copy of Lease Agreement (and Landlord’s municipal account) – Compulsory**
- **CSD summary report – Non-Compulsory**
- **Joint Venture Agreement (In case of a Joint Venture) – Compulsory**
- **Joint Ventures must be registered on CSD as Joint Venture**
- **Local content is applicable as per MBD 6.2 as well as Annexure C – Compulsory**
- **Approval of exemption on local content from DTI must be attached with bidding document, as and when applicable – Compulsory**
- **All forms must be completed in full – Compulsory**
