REFURBISHMENT OF VAALBANK WATER PURIFICATION PLANT - PHASE 3

In terms of Section 110 of the Municipal Finance Management Act, 2003 (No. 56 of 2003), tenders are hereby invited for Refurbishment of Vaalbank water purification plant - Phase 3, in the Steve Tshwete municipal region. **Tenderers should have a CIDB contractor grading of minimum 7CE, 7EP & 6ME.**

Only payments made in cash or debit/credit card will be accepted.

Fully completed tender enclosed in a sealed envelope marked "TENDER NO. BS03/10/2023: REFURBISHMENT OF VAALBANK WATER PURIFICATION PLANT - PHASE 3" with the name of the tenderer, shall be deposited in the tender box provided at the Steve Tshwete Local Municipality on the 1 st floor, Room B207, Civic Centre, Corner Walter Sisulu and Wanderers Avenue, Middelburg, before 12H00 on 29/11/2023. The tenders will be opened in public.

A **compulsory** clarification meeting will take place on 08/11/2023 starting at 10:00, at Library Auditorium, Gerald Sekoto Library, Civic Center, Cnr Walter Sisulu & Wanderers, Middelburg, 1050

*Bidders will be evaluated on functionality whereby **70 points** has to be attained before financial proposals can be looked at. A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the conditions of tender in the tender document, read in conjunction with the supply chain management policy of Steve Tshwete Local Municipality where **90 points** will be allocated in respect of price and **10 points** in respect of Specific Goals. Tenderers must have the necessary skills, experience and capacity to perform the required work.*

No awards will be made to a person:

- Who is in the service of the state;
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.

- **Joint Venture Agreement (In case of a Joint Venture) – Compulsory**
- **Joint ventures must be registered on CSD as joint venture**
- **CIDB grading of minimum 7CE, 7EP & 6ME – Compulsory**
