RESOLVED BY COUNCIL

1. **THAT** Council rescind Resolution C08/12/2020 especially the item relating to indigent household.
2. **THAT only** household who applied for indigent disqualified due to letter of authority be brought back into the indigent register.
3. **THAT** indigent applicant with missing documentation be considered indigent.
4. **THAT** applicants with affordability disqualification not be considered.
5. **THAT** all applicants be given six (6) months to submit all outstanding information for them to be regarded as legitimate indigents.
6. **THAT** Council consider deviating from the Credit Control Policy to allow community to purchase electricity regardless of the outstanding debt for a period of one (1) month from the date of the Council Resolution subject to the Executive Director: Financial Services submitting monthly reports to Council meetings until the matter is resolved.
