

1. **THAT** note be taken that on 03 September 2021 the Concourt dismissed the Electoral Commission application for the constitutional amendment order to hold the Local Government Elections (LGE) no later than the end of February 2022.
2. **THAT** the date of the LGE as published in the Government Gazette attached as **ANNEXURE A** to the Agenda is set for 01 November 2021.
3. **THAT** the Amended Election Timetable as published in the Government Gazette attached as **ANNEXURE B** to the Agenda, be noted.

1. **THAT** Council take note and consider the report by the Executive Director: Corporate Services with regards to the Salary and Wage Collective Agreement attached as **ANNEXURE A.**
2. **THAT** Council approve implementation of the SALGBC Salary and Wage Collective Agreement with regard to the Salary and Wage annual increase for the period 1 July 2021 to 30 June 2022 where the details of the increase are contained in the attached **ANNEXURE A.**
3. **THAT** Council take note of the annual across the board increase from 01 July 2021 to 30 June 2022 of three point five percent (3.5%) for all employees covered by the collective agreement.
4. **THAT** Council take note of the once off non-pensionable allowance payment of R4000 and R3000 that will have to be paid to employees earning R12 500 and less and those earning R12 501 and more respectively in accordance with the SALGBC agreement.
