OPENING


1.1 The Speaker welcomed all present and declared the meeting opened.

1.2 RULING OF THE SPEAKER

With the opening of the Special Council meeting and after various Councillors discussed the notice of the meeting, the Speaker, Cllr Mpye made the following ruling:

"Due to the following reasons, this meeting is declared null and void"

1. The heading of the motion is no confidence in the Executive Mayor while Section 87 of the Rules of Order determines is the removal of the Executive Mayor.
2. That in terms of Section 4(1) of the Rules of Order, the Speaker decides when and where the Council meets while with this meeting, the Municipal Manager decided the time, date and venue of the meeting.



3. That according to the Rules of Order, the Speaker must chair this kind of meeting and not the Municipal Manager.
4. That in terms of Section 4(2) of the Rules of Order, 50%+1 (a quorum) must request a meeting of this kind."

Therefore the meeting was declared "Null and Void" by the Speaker.
