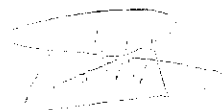

1 OPENING

1.1 The Municipal Manager welcomed all present and declared the meeting opened.

1.2 Ruling of the Municipal Manager

With the opening of the Special Council meeting, Cllr WMM Phetla raised a point of Order and denounced the meeting as illegal, averring that the meeting should have been convened in terms of Section 4 of the Rules of Order, not Section 86 as indicated in the Notice.

After some lengthy deliberations and debating on the matter the Municipal Manager made the Ruling that the meeting was legally convened in terms of Section 86 of the Rules of Order, therefore it should be continued with the meeting.

The Ruling by the Municipal Manager was contested by some Councillors, and subsequently after some further deliberations and consecutive caucus periods requested, the Municipal Manager requested a caucus period with the Whips of the Political Parties in Council.

Consequently and in view of the preceding, the Municipal Manager made a Ruling in terms of 1.5 under Interpretation and Section 19 (3)(a) of the Rules of Order, and refer the matter to the Rules and Ethics Committee for consideration.


However before the adjournment of the meeting he indicated that although the ruling regarding the Notice of the meeting is referred to the Rules and Ethics Committee, the content of the Motion still stands for discussion.

Therefore the meeting was adjourned by the Municipal Manager.
